# Vendor Agreement

**Deadline for Application & Agreement: September 30**  
Children's Area Booth and Food Vendors are open 11am-3pm

I understand and agree to the following:

1. All vendors must be self-contained. (You must provide your own generator if electricity is needed.)
2. The City and Palm Desert Chamber do not provide water, ice or electricity. Food/Drink Vendors are expected to supply their own tables, chairs, canopy, etc. for booth. Children's Booths will work with Chairman on table and chair needs.
3. You will be assigned a specific location on Larkspur (location of children's activities) and El paseo (Food Vendors). You agree to the location identified on the City approved map for the event.
4. Vendors must be set up before 10:00 a.m. on Sunday, October 23, 2011. Health Department inspection is at 10am. and all vehicles parked in **assigned area**.
5. After event, all vendors must clean up their space completely, taking all unused product, boxes, supplies, etc. with you. No trash or debris of any kind may be left.
6. **ALL VENDORS MUST OBTAIN A CITY OF PALM DESERT SPECIAL EVENT PERMIT** to participate.
7. Vendors shall provide a **\$1,000,000 general liability insurance policy** covering the City of Palm Desert, the Palm Desert Chamber of Commerce. Your certificate of insurance must accompany this agreement.
8. **INSURANCE WAIVER:** Vendors agree to hold harmless the City of Palm Desert, Palm Desert Chamber of Commerce and the Golf Cart Parade Committee, its officers, staff and volunteers should an incident occur.

In order to ensure proper coordination of types of food and supply of each type, please do not make changes in your product or food items without approval of the Vendor Committee Chairperson.

# General Information

**Parade Date:** Sunday, October 23, 2011  
Deadline for Vendor Application & Agreement: September 30, 2011

**Fees:**  
Space Fee Commercial Vendor \$200 per site  
Space Fee Non-Profit Vendor \$75 per site  
Children's Activities Booth FREE

**Parade Route:** South side of El Paseo Dr. in Palm Desert

**Vendor Area:** North side of El Paseo Dr. in Palm Desert (Specific sites within the designated area are determined by the Parade Vendor Chairman.)

**Children's Activities Area:** On Larkspur, just south of El Paseo.

**Time for Sales:** Vendor booths will be open for business from 11:00 am until 3:00 pm.

## **Who can be a Vendor?**

Anyone providing food or non-alcoholic beverage products may apply. (Sale of non-food or beverage items is not permitted.) The Vendor Chairman seeks a variety of food products.

## **Who can have a children's activity?**

Agencies who will have hands-on activities for children/families. Feel free to bring materials from your institution as well.

## **What are the Specific Requirements for Vendors with food/drinks?**

1. You'll need a Health Department permit. Contact the Riverside County Environmental Health Department at (760) 863-8287.
2. You'll also need a special event one-day permit from the City of Palm Desert. It is available at Palm Desert City Hall, Community Services Building, Business License Department. This is for all vendors. (The fee for non-profit vendors is waived, but you must still apply for the permit.) Contact Business License Department at (760) 346-0611, ext 443.
3. You need to be set up and ready the day of the parade for a Health Department inspection beginning at 10:00 am. You can open for business at 11:00 am. The Vendor Chairman will begin assigning spaces at 7:00 am.

## **How Can I Apply for a Vendor or Children's Activity Booth/Site?**

Complete both the application and agreement (pages 1 & 2), and mail, along with your vendor fee and certificate of insurance, to:
